



## Wishing You Wellness

### Subsidized TransAlta Tri Leisure Centre Pass/Membership - Application Process & Guidelines

#### Description

The Wishing You Wellness Program facilitates community inclusion by removing barriers to access, where affordability for the recreation services offered at the Tri-leisure Centre falls outside the scope of a basic living wage. The WYW program helps to foster healthy community connections, resulting in a sense of belonging and the long-term physical and mental benefits of a health and wellness regime.

#### Guidelines

**Subsidization is based on income verification, need, and the availability of foundation funds; there is no guarantee that all requests will be accommodated; access to funding is on a first come, first served basis.**

- Subsidized access will be provided for qualifying adults, seniors, youth, children and families residing in Parkland County, City of Spruce Grove or Town of Stony Plain who experience low income.
- TLC Passes/Memberships are subsidized in two ways:
  - the TLC discounts the regular price of Passes & Memberships that are part of this program.
  - the Westview Health Centre Foundation (WHCF) makes one-time or ongoing contributions towards the cost of the Passes & Memberships that are part of this program.
- Approved applicants will receive a letter from the Westview Health Centre Foundation and must present this at the TLC Customer Experience Desk within 30 days of the letter's date of approval.
- The total subsidy amount approved will be at the discretion of the WHCF and will be provided as a 75% discount by the WHCF & the TLC.
- A 25% Customer contribution is required.
- Any approved applications are non-transferrable and must be used by the person(s) living in the approved household.
- Available TLC products are:
  - Multi Visit Pre-Paid Pass
  - One Month Pre-Paid Pass
  - Monthly Continuous Membership\*
  - Pre-Paid Annual Membership\*\*

#### Application Process

**All Wishing You Wellness applications will be held in the strictest confidence.**

**To qualify for subsidized access, the applicant(s) must reside in Parkland County, the City of Spruce Grove, or the Town of Stony Plain, and have a household income no higher than the amount in the table below:**

## Wishing You Wellness

- **Apply at one of the following regional referral agencies:**
  - Stony Plain Community & Social Development
  - Westview Primary Care Network
  - Spruce Grove Community & Social Development
  - Alberta Parenting for the Future Association
- **Provide confirmation of family income to demonstrate financial need by supplying a copy of one of the following:**
  - Income Tax Notice of Assessment from previous year
  - Last pay stub
  - AISH statement
  - Alberta Child Health Benefits Program approved letter.
  - Current Alberta Health Benefits Program card
- **Provide proof of residency in Parkland County, City of Spruce Grove, or Town of Stony Plain by supplying a copy of one of the following:**
  - Notice of Assessment (showing your current address)
  - Current bank statement
  - Municipal tax notice with current address and/or legal land description
  - Recent utility bill
- **Provide proof of financial assistance that you are currently receiving by supplying a copy of one of the following:**
  - AISH
  - Income Support
  - Guaranteed Income Support
  - Alberta Seniors Benefit
  - Health Records
  - CPPD
  - Refugee Status
- **Complete a Subsidy Application Form indicating type of TLC pass/membership for each household member.** (different products for individual family members optional – Membership agreement(s) to be completed at the TLC)

\* Automatic debit from bank account, MasterCard or Visa. Lasts for 12 months (pause months or cancel anytime). Prices increase by approx. 2.5% each January 1. Children turning 13 years old automatically move to youth pricing.

\*\*Pay in advance, non-refundable but can pause for up to 63 days in the 365 in a minimum of 7-day increments.

- **Once your application is reviewed by the referral agency you will be contacted,**
- **If approved, you will receive a confirmation email from the Westview Health Centre Foundation with next steps on how to activate your pass or membership at the TransAlta Tri Leisure Centre.**
- **All Wishing You Wellness applications will be held in the strictest confidence.**
