# **PAYMENT BREAKDOWN**

TLC Active Kids Preschool program fee is \$1800 for 68 classes occurring between September-June. Included in this rate, your child will receive an annual Preschool Pass, giving them access to early member registration and pricing for TLC programs!

### **STEP 1: REGISTRATION**

A deposit of \$180 is required at the time of registration to secure your child's spot. This deposit will be refunded to families once the child competes the program in its entirety without any incidentals to a monthly payment.

**STEP 2: MONTHLY PAYMENTS** 

- Monthly payments will be made through automatic withdraw from a Visa or MasterCard on the second Wednesday of each month (Visa Debit not accepted).
- Based on each family's subsidy eligibility, we will automatically reduce your monthly fee by your approved amount prior to processing any payment.

## WITHDRAWL POLICY

Withdrawal notice must be provided **before the first of the upcoming month** to avoid charges on the next payment date. If notice is not received before the first and the child attends any classes during the month, the full monthly fee will be charged. No partial refunds or prorated fees will be issued.

You may be eligible for a refund on your deposit depending on the withdrawal date. The following portion of your \$180 deposit will be refunded based on the date we receive written notice

If your child completes the program in its entirety without any incidentals to a monthly payment, the \$180 deposit with be refunded back on the account two weeks after the final monthly payment.

# TLC Active Kids Preschool

## SUBSIDY INFORMATION

TLC Active Kids Preschool is a licensed facility under Alberta's Early Learning and Child Care Act, allowing our program eligibility for operator and parent subsidies.

In fall 2021, a Provincial/Federal child care agreement was signed to support the expansion of accessible, affordable and high-quality child care that also gives families the choice of providers. This plan will reduce fees for parents of children zero to kindergarten age to an average of \$10 per day child care by 2026.

To achieve this goal, the Government of Alberta will give grants to child care providers that will lower fees for all parents. Families who make less than \$180,000 will be eligible for an additional subsidy to further reduce their child care costs.

### **OPERATOR AFFORDABILITY GRANT**

- TLC Preschool will receive \$75 each month for every child registered, which will reduce our monthly fee from \$180 to \$105 for all families.
- This agreement is in place until December 2026 and we hope for it to continue into next year.

#### PARENT SUBSIDY

- Parents with a family income under \$180,000 a year could also benefit from subsidies to further reduce child care fees by a maximum of \$125 per month.
- Eligible families will need to apply and receive approval for a parent subsidy through the Government of Alberta's Child Care Subsidy page (https://www.alberta.ca/child-care-subsidy.aspx).
- Once you have been approved, please let us know and we will ensure you are in our system. Each month we will apply subsidy payments for approved families. You will still be sent a receipt with your balance reduced by \$180 each month.
